The Essential Guide to Producer Compliance for the Lamp Industry





## **WEEE Regulations**

The Waste Electrical and Electronic Equipment (WEEE) Directive was first incorporated into UK Law as the WEEE Regulations in January 2007. The regulations were recast in 2013 and brought some minor updates to the Directive which will be introduced in the UK on various dates between 2014 and 2019. The WEEE Regulations place responsibilities on Producers (Manufacturers, Importers or Re-branders) of Electrical and Electronic Equipment (EEE) that is placed on the UK market. Producers who place more than 5 tonnes of EEE on to the UK market each year are required by law to register with a Producer Compliance Scheme (PCS).

# **Small Producer Registration**

Since January 2014, Producers placing less than 5 tonnes of EEE on to the UK market have two registration options:

- Register directly with the Environment Agency
- Register with a PCS who will administrate your registration and ensure you fulfil
  your obligations under the UK WEEE Regulations

## How do I select an appropriate PCS?

Finding a suitable Producer Compliance Scheme can be confusing, especially if you are a producer of both Business to Consumer (B2C) and Business to Business (B2B) EEE. There are varied membership offers available across the UK but by understanding some of the basic requirements, becoming compliant is a fairly simple process. There are PCSs that are specific to B2B and B2C and there are those that do both. The golden rule when deciding on the appropriate PCS for you is to do comparisons and ensure when you do them that you are comparing "Apples with Apples". Cheap initial offers may seem good but it's the costs that are not declared that you need to be wary of.

# Don't be fooled by statements such as:

- We are the preferred PCS for your particular sector"
- We have the cheapest membership fees"
- We are the largest compliance scheme"
- We are a not for profit organisation"
- WEEE Compliance for £3 per tonne",etc.

## The Essential Guide to Producers of B2C and Both

When registering as a Producer you will be required to pay an Environment Agency fee which is standard across all PCS's.

Membership fees and other charges however are not, and we believe that by asking the following relevant questions you will be able to make the best decision on which PCS is right for you.

- 1. Based on the quantities of EEE | place on the UK market would it be cost effective to run my own compliance scheme?
- 2. What is the cost of membership and:
  - What do | get for that?
  - Are there any additional charges to pay?
  - Do you have an online service for quarterly submissions?
- 3. What mechanism do you use for charging market share obligations for B2C WEFF collected?
- 4. Do you offer any incentives if I collect my own WEEE?
- 5. What are the costs associated with collecting B2B WEEE from my location and do | pay in advance?

These questions may seem confusing but it is essential that you understand them and the answers provided will ensure you do not pay more than you need to. As a Producer you have to join a PCS, just make sure you get cost effective compliance.
