## Term & Conditions:

### 1.0 Interpretation

- 1.1 "Conditions" means the standard terms and conditions of supply herein set out and include any special terms and conditions agreed in writing between the Customer and AVC Weeeco Ltd
- 1.2 "Customer" means the person or company whose order for a product is accepted by AVC Weeeco Ltd.
- 1.3 "Contract" means the contract for the supply of a product.
- 1.4 "Order" means that order placed by the Customer which is accepted by AVC Weeeco Ltd subject to the provisions of Clause 2 below.
- 1.5 "Force Majeure" means any circumstance beyond the reasonable control of AVC Weeeco Ltd.

### 2.0 Formation of Contract

- 2.1 An order sent to AVC Weeeco Ltd by the Customer shall be accepted entirely at the discretion of AVC Weeeco Ltd and if so accepted shall be subject to these Conditions.
- 2.2 Within seven days of receipt of an Order AVC Weeeco Ltd shall forward the customer an acknowledgement of the Order (via email, fax or post), setting out the details of your order.
- 2.3 Your Order represents an offer to us to purchase a product, which is accepted by us when we send confirmation (via email, fax or post), stating that we've dispatched that product to you (the "Dispatch Confirmation").
- 2.4 That acceptance will be complete at the time we send the Dispatch Confirmation.
- 2.5 Any products on the same order which have not been confirmed in a Dispatch Confirmation as having been dispatched, do not form part of that contract.

### 3.0 Contract Price

- 3.1 The price of the Contract shall be agreed between the parties and confirmed by AVC Weeeco Ltd's acknowledgement of the Order.

### 4.0 Terms of Payment

- 4.1 The payment in full must be provided with the order (via cheque or postal order – payable to AVC Weeeco Ltd).
- 4.2 Any orders sent without payment will not be processed until full payment has been received.

### 5.0 Return a Damaged or Defective Item

- 5.1 This returns policy does not affect your statutory rights.
- 5.2 If you take delivery of a AVC Weeeco package and the contents have been damaged in transit, you can return the item(s) to us within 30 days of receipt for exchange.
- 5.3 You have the right to return a faulty item within 30 days of receipt of exchange.

**Note:** In the event of AVC Weeeco Ltd sending you a replacement for a damaged or defective item you must return the original item to AVC Weeeco Ltd within 30 days before the replacement item will be sent out. Provided you return this item to us within the 30 days, you will have nothing more to pay.

### 6.0 Force Majeure

- 6.1 AVC Weeeco Ltd shall not be under any liability for failure to perform any of its obligations under the Contract due to Force Majeure.

### 7.0 Third Parties

- 7.1 In making arrangements with third parties for carriage, AVC Weeeco Ltd acts only as the agent of the Customer and does so on the express condition that no liability of any kind howsoever arising shall accrue to AVC Weeeco Ltd in connection with such arrangements.

### 8.0 Liability

- 8.1 AVC Weeeco Ltd shall not be liable to the Customer nor deemed to be in breach of the Contract by reason of any delay in performing, or any failure to perform any of the AVC Weeeco Ltd's obligations, in relation to the Contract if the delay or failure was due to any cause beyond AVC Weeeco Ltd's reasonable control.
- 8.2 In any event AVC Weeeco Ltd's total liability hereunder shall be limited to 10% of the Contract price and AVC Weeeco Ltd shall have no liability for any consequential or indirect losses suffered by the Customer.

### 9.0 Variations

- 9.1 No variations to the above conditions may result in cancellation of the Contract without notice.

### 10.0 Failure to comply

- 10.1 Failure to comply with these conditions may result in cancellation of the Contract without notice.

### 11.0 General

- 11.1 Any notice required to be given by either party to the other shall be in writing and addressed to that other party at its registered office or principal place of business or such other address as may at the relevant time have been notified pursuant to this provision to the party giving the notice.

### 12.0 Applicable Law

- 12.1 The Contract shall be governed by the laws of England and shall be subject to the exclusive jurisdiction of the English Courts.
